Stated succinctly, the following took place at the meeting of 21 July 2021;

The insolvency practitioner declared that he complied with the regulations of Sections 109, 114 and 115 of the Bankruptcy Act (Fw).

None of those present wish for the delegated judge to read out the list of provisionally allowed claims drawn up by the insolvency practitioners and filed with the registry of this court on 13 July 2021.

The insolvency practitioner contests ninety claims amounting to a total of €189,819.39. A copy of the list of unsecured creditors contested by the insolvency practitioners, including a statement of the reason for the contestation, has been attached to the official report.

As the parties have been unable to reach agreement, the delegated judge refers the parties with respect to the aforementioned contested claims to the hearing of this court of:

Wednesday, 20 October 2021 at 10.00 hours.

The delegated judge orders that the aforementioned claims contested by the insolvency practitioner be transferred to the list of contested claims and that all other claims included in the list of unsecured claims provisionally allowed by the insolvency practitioners, including the records of priority or otherwise belonging thereto, are transferred to the list of

allowed creditors.

With due observance of the matters set out above and as no one has any further objections to the verification of the claims presented for verification by the insolvency practitioner, the claims submitted are transferred to the **following lists of allowed and contested creditors:**

The insolvency practitioner reports on the status of the assets and refers in this connection to the financial report of 13 July 2021, a copy of which has been attached to this official report.

The delegated judge closes the meeting as no one else makes any request or wishes to address the court.
